

## **TERMS & CONDITIONS**

1. Topps IPL Cricket Attax Trading Card Game scratch and win program is a limited period offer ("Offer") valid from April 1, 2016 to December 31, 2016 both days inclusive ("Offer Period"), organized by Topps India Sports & Entertainment Company Private Limited, a company incorporated under the Companies Act, 1956 and having its office at Address-Unit no: 104, 1st floor, B - wing, 36-B Turner building, Turner Road, Bandra-West, Mumbai-400050
2. The Offer is open to citizens of India resident in India only. Citizens of foreign countries residing in India and non-resident Indians are not eligible to participate in this offer.
